

ORDINANCE NO. 19

AN ORDINANCE OF THE TOWNSHIP OF MONTGOMERY, COUNTY OF INDIANA AND COMMONWEALTH OF PENNSYLVANIA, PROVIDING FOR THE ESTABLISHMENT OF STOP INTERSECTIONS AND THE PLACING OF OFFICIAL STOP SIGNS AND CONFIRMING THE EXISTENCE OF THE SAME.

BE IT ORDAINED AND ENACTED by the Township Supervisors of Montgomery Township, Indiana County, Pennsylvania, it is hereby ordained and enacted as follows:

1. The following intersections are hereby established as stop intersections and official stop signs shall be erected, the erection of which is hereby confirmed, in such a position so as to face traffic approaching the second named highway upon the first named highway. All vehicles approaching any such intersection upon the first named highway shall come to a full stop at a reasonable distance before entering such intersections.
