Old Business:

Hazelet Road Culvert: The township did not obtain the money from Soil Conservation. To apply for the multimodel Grant an engineering study would have to be done in advance of the application and there isn't enough time to have all the items completed before the deadline. The supervisors will contact Cranberry Township to see how they installed a pipe inside a pipe, find out the cost and what other steps this township completed to finish their project.

Dangerous Building: Nothing has been done to the old Nemurget house in Arcadia. Bill is going to contact Jeff Sweeny, the contractor that Ms. Deyarmin said she hired to demolish the structure.

Snow Fence: Bill got a price of \$58.14 for 50 feet of fencing. Ed motioned to buy 10 rolls of fencing, second Kevin, Carried.

Multimodel Transportation Fund Grant Application: This item was discussed under Hazelet Road Culvert.

New Business:

Trick-or-Treat: The Supervisors set Saturday, October 31, 2020 from 2:00 PM to 5:00 PM as the designated date and time for Trick-or-Treating in the township with the motion made by Ed, second Kevin, Carried.

2021 Budget: The secretary asked if the supervisors had any plans to make any purchases of equipment so it could be allotted in the budget. The supervisors said that there is nothing foreseen that will be needed in the upcoming year.

Police Report: The report was read by Dave Angelo. John Blake has officially resigned and Dave Angelo will now assume all of his duties. The township received free hours of patrol from the DUI task force grants. The police are still attempting to recruit new hires. And PSP DOT will be contacted and asked for assistance with the overweight trucks traveling on the Cherry

Tree Road. There was one call for a disturbance with shots fired. Hours worked 19.0 hours at \$30.00 an Hour for a total of \$570.00
