Security Cameras: Bill found a camera that fits the criteria and will order and install

ATV Ordinance: A discussion was held during Kevin is going to talk to some supervisors who already have an ordinance in place. Bill motioned to table until the next meeting, second Kevin.

New Business:

Plowing 4/10 mile of Benzie Road for Burnside Township: A discussion was held and concerns were expressed on the dangers of taking over plowing this road. Bill motioned to not plow this road second Kevin.

Permit Fee for Loads under Five: A discussion was held. Kevin motioned to set the fee to haul loads of logs under five at \$50.00 and state in the Permit that any damages that occur will be paid by the logging company, second Bill.

Jan Arford Alley Way in Hillsdale: Jan asked if the Supervisors were going to do anything about opening the alley and the Boards response was the same as it had been a few years ago that the alley way is not a township road so the township does not have any control over it and they advised Jan to get an attorney and not take the law into her own hands. The letter in response to Jan's from the Township Solicitor was read by Kevin Penrose which stated that in order for the alley to be a public road it would have to be 33 feet wide and Jan had already stated in her letter that it was only 21 feet wide and that the Sections of the Township Code that Jan had referenced were for Public Roads not alley ways and the Township would have had to have maintained the alley for 21 years in order for it to belong to the township and since they didn't the township has no control over it.

Police Report

Chief Scherf read the report. Officer Zachary Killeen is certified as a police officer in Pennsylvania. He has completed 25 hours of patrol in the township and will be able to go out on his own in October. Cherry Tree Borough is paying for Officer Kileen's training hours. They are hoping to have the hours up to 50 in September. Numerous traffic stops were made which resulted in drug related arrests and citations. They responded to a domestic disturbance and made an arrest for simple assault. They responded to one Criminal Mischief report and made one criminal arrest. They worked a total of 25 hours for the month at \$30.00 per hour for a total of \$750.00. Chief Scherf also went over the method they use to issue speeding tickets. He stated that a stop watch is used and they give a 10 mile per hour cushion. No citations have been written for speeding this year.
