Update on ATV Ordinance: A copy of a proposed Ordinance was reviewed. Bill mentioned that he didn't see a time frame in the Ordinance. Motion to send a copy to the Solicitor, Wayne Kablack made by Ed, second Kevin, carried. Kevin requested that the secretary ask the Solicitor what the Liability to the township would be if someone wrecks and if the supervisors can be held responsible and if there is a need to add a time frame in the guidelines, second Kevin, carried.

Update on Road Study for Stiffler Road and Irwin Hill Road: Nothing has been received from PennDot.

Update on Money Market Fund and Additional CD Investment: An estimate of what would be gained in interest was reviewed by the Board. A discussion was held. Kevin motioned to set up a Money Market Account for the General Fund and deposit \$267,250.19 out of the General Checking, then to close down the General CD and Deposit the full amount of \$32,749.81 into the General Money Market for a total of \$300,000.00 From the State Checking \$100,000.00 to be deposited into a State Money Market Account and to close both State CD's and deposit the total of

\$16,231.42 into the State Money Market Account for a total of \$116,231.42, second Ed, carried.

New Business:

List Ntherm as Electric Supplier: Bill motioned to not list Ntherm as electric supplier, second Ed, carried

2022 Audit Report for Glen Campell Fire Relief Association: The Auditor General listed the problems that had been found during the Audit as untimely receipt and deposit of State Aid.

Police Report

Zach Kileen read the report for July. Conducted speed checks on SR286 in Hillsdale, conducted security checks on open and closed businesses, responded to a disturbance on Cherry Tree Road, conducted speed check on 286 and investigated a missing juvenile who was later found and transported home. 
2023 Recycling Dates – September 30 and November 04. There will be no collection in October.
