

MONTGOMERY TOWNSHIP

LOCAL SERVICE TAX INSTRUCTIONS & RETURN FORM

The Local Service Tax is levied on all business owners, self-employed individuals and employees working within Montgomery Township and the Purchase Line School District. Purchase Line School District is charged with the administration and enforcement of this tax.

WHO IS TAXABLE:

- ♦ All owner/operators, self-employed individuals and employees **who receive earnings of at least \$2,000** from income, salary, wages, commissions and fees.
- ♦ Occupation(s) shall mean any trade, profession, business or undertaking of any kind, type or character, including services, domestic or other, located within the taxing district shown above.

ALL EMPLOYERS AND BUSINESS OWNERS ARE RESPONSIBLE FOR COLLECTING AND SUBMITTING THE LOCAL SERVICE TAX TO THE TAX COLLECTOR.

- ♦ *The Local Service Tax is a payroll deduction tax of \$10 which must be paid ONCE PER YEAR.*
- ♦ Individuals having more than one employer during the tax year should have the Local Service Tax deducted by one employer only.

DEADLINES FOR FILING THE TAX

- ♦ Tax returns are due on April 30th for anyone earning \$2,000 in the first quarter of the year. If the \$2,000 income level is reached after March 31st, the tax should be submitted according to the following deadlines: Second Quarter - July 31st; Third Quarter - October 31st and Fourth Quarter - January 31st.
